

Visiting Fellowships and Scholarships 2021-22

1 The Institute of Modern Languages Research

The Institute's aim is to promote and facilitate high-quality research in Modern Languages and/or Latin American Studies, making it available to the widest possible audience both inside and outside the academic community. The Institute's main areas of activity are:

- Events
- Publications
- Research collaborations and networks
- · Research training and the supervision of research students
- Post-doctoral research and Visiting Fellowships

2 Visiting Fellowships and Scholarships at the IMLR

Visiting Fellowships and Visiting Scholarships are available on a non-stipendiary basis in all the fields of research covered by the Institute, as well as in interdisciplinary studies. Applications in comparative and cultural studies are particularly welcome. Non-stipendiary Fellowships/Scholarships can be held within one of the Institute's seven research centres:

- Centre for Latin American and Caribbean Studies
- Centre for the Study of Cultural Memory
- Centre for the Study of Contemporary Women's Writing
- Ingeborg Bachmann Centre for Austrian Literature
- Research Centre for German and Austrian Exile Studies
- Centre for Quebec and French-Canadian Studies
- Ernst Bloch Centre for German Thought

The Fellowships are open to applicants from the UK and overseas. Applicants for Visiting Fellowships should have completed their doctorate and have a strong publications record. Doctoral students may apply for Visiting Scholarships using the same application procedure.

3 Tenure

Fellowships are tenable for any period from one to ten months between 1 September 2021 and 30 June 2022. Extensions to the original period of the fellowship may be possible, but will be subject to the same terms.

4 What the Institute offers

The Institute can offer office accommodation shared with other Fellows, with wifi, internet, email account, photocopying/printing facilities, and access to the University of London's Senate House Library, where the holdings in Germanic Studies and Latin American Studies are world class. Senate House Library has a substantial collection of books, journals, online resources, theses and archives in all the Modern Languages fields. Fellows can access the libraries of the other Institutes that make up the School of Advanced Study: Advanced Legal Studies, Classical Studies, Commonwealth Studies, Historical Research, and the Warburg. Fellows are offered free access to all the Institute's events and are expected to participate as much as possible in the intellectual life of the Institute.

5 Requirements

Fellows/Scholars contribute to and enhance the scholarly activity of the Institute and the School of Advanced Study. In addition to presenting current work as a seminar or as part of a larger conference, Fellows/Scholars are invited to organise an event either during or resulting from their stay, or otherwise contribute to the work

of the Institute. Fellows/Scholars are invited to place a recent, normally unpublished, piece of work in our free open access repository <u>SAS-Space</u>, and to contribute to the IMLR blog, <u>Living Languages</u>. Publications resulting from research conducted during the tenure of the Fellowship must acknowledge the Institute and, where appropriate, a copy should be deposited in Senate House Library or with the Institute Director. At the end of the tenure period, Fellows/Scholars must produce a short report on the activities undertaken at the Institute and progress made in their research.

6 Accommodation

Living accommodation is not provided and Fellows should make their own arrangements. A list of hotels and guest houses is available <u>on our website</u>, and the University of London <u>Accommodation office</u> may also be able to assist.

7 Visas

Fellows that do not have the right to reside and/or study in the UK will require a visa and must ascertain what category of visa is most suitable for them. You may be eligible to apply for a <u>Standard Visitor Visa</u>, which permits academics to visit for research purposes for periods not more than six months.

8 Method of Application

Applicants must submit the attached application form by the deadline of **14 May 2021** together with:

- a statement detailing your research project and intended outputs (no longer than 1,500 words)
- a statement outlining the ways in which you would contribute to the work of the Institute (500 words)
- a curriculum vitae (no longer than 2 pp)
- a publications list (not more than 2 pp)

You must also arrange for two academic references specific to the Fellowship/Scholarship application to be sent by the closing date, direct from the referee, to Cathy Collins, Institute Manager, IMLR (cathy.collins@sas.ac.uk).

Interviews will not be held and applicants will be notified of the result of the competition by the end of June 2021.

9 Closing Date

The closing date for receipt of applications and references is 14 May 2021.
